
## Skipper Grove (The Orange Park Subdivision History)

A working draft of the history of the South Lake Morton & Cumberland-Biltmore Historical Districts

Many of these represent individual orchards that were purchased and developed. Following is a diagram showing known orchards that have since been developed:




Today, only one grove remains, south of Lake Morton (and perhaps in all of Lakeland, to this author's knowledge). It is located along the Lake Hollingsworth creek, exiting Lake Hollingsworth approximately southwest. That orchard is not within the Districts discussed here, but is of note, being one if not the only remaining grove within Lakeland's city limits.



That noted, the Orange Park Subdivision is a direct result of developers purchasing a grove and developing it. That grove was known as Skipper's Grove. This is the focus of this document.

## Skipper Grove (orange & grapefruit) - 1904




The Skippers were among the early settlers of Lakeland. Joseph Lee Skipper was born in Bartow in 1856, the son of John Levi Skipper and Elizabeth Jane Hollingsworth. He is notable for several reason but history most-often recalls how he was Lakeland's postmaster from 1898 until 1914. His brother Enoch had been postmaster of Bartow for a few years during that time. When he passed away in 1947 at the age of 83, he was a trustee and steward of the First Methodist Church as well as being a 32rd degree mason. Also, after he completed his postmaster duties, he later became president of the Lakeland Citrus Growers Association.


Among his business ventures, he purchased a 13-acre grove for \$5,000 in 1904. The grove was on Lake Morton's south shore and was often referred to as simply Skipper's Grove. On it he grew oranges and grapefruit trees. The grove was bound at the south by McDonald Street (now Frank Lloyd Wright Way). Success Avenue ran along the west edge. The east edge ran where today's alley/easement divides the lots between Mississippi and Johnson Avenues.

The Florida-Georgia Land Company (FGLC) incorporated in Lakeland at the end of January 1912. The new company was a merger between the existing companies of Carter-Deen Realty and Scally & Bassett, including \$50,000 in capital they could use to acquire and develop property. Carter-Deen Realty Company was an experienced development company already, having re-platted and expanded the original Dixieland subdivision in 1907 - the largest of the two-dozen plats that combine to form the South Lake Morton Historical District. Scally & Bassett was also a Lakeland-based developer and real estate broker, both focused on farm land suitable for residential development. At about the same time in 1912 (May 25) Joseph, his wife Minnie (nee Nunnelly) and their youngest son Roscoe Nunnelly and their friend John Edwards, incorporated in Lakeland as the Skipper Realty Company. They incorporated with \$20,000 of capital.


At some time between 1904 and 1912, he has sold a half-interest in the grove and, on June 18, 1912, he sold his remaining half-interest to L.M. Futch, C.M Clayton, C.W. Deen and others (who already owned the other half). These new owners, including C.W. Deen of Carter-Deen Development Company, immediately resold the grove on June 23, 1912, to FGLC for \$30,000. By June, FGLC had filed a plat for a new residential subdivision that encompassed the entire grove. They called the new development Orange Park.



The lots were ready for sale by September, after the sewer and power and roads had been briskly installed. The lots sold from \$600 to \$1,250, on terms. Among the selling points was that each lot included an average of six mature orange and/or grapefruit trees. Buyers of these lots would not own the fruit from the 1912 harvest as it had already been contracted for; however, they would own the fruit after that. Each tree was estimated to be worth \$100 per year in fruit harvest.



Some of the trees did not survive long though as purchasers of these lots were required to build a home of no less than \$1,500 in cost, to ensure quality, fashionable homes would be built. Though construction was particularly brisk, certainly many of the large fruit trees would require removal to make room for new cottages and bungalows.



In January of 1913, investors from Michigan bought several lots in Orange Park, followed by an investor from Ohio in February. As of March, only a fraction of lots costing \$800-\$850 remained unpurchased. By July, most of the lots had sold and FGLC was off working on a brand new subdivision in the city of Auburndale. Averaging the 106 lots in Orange Park for \$800, FGLC may have grossed \$85,000. Less what was paid for the land would have left \$55,000. If they were able to complete all the improvements for less than \$25,000, they would have netted \$30,000 (doubling their initial investment).

Home building in Orange Park began slowly in late 1913, but by the fall of 1914 Thomas Waring had engaged W.R. Wilson of Tampa to build five modern bungalows on lots he held. They were to have concrete piers installed by B.H. Bellisario and

each home was to have five or six rooms. He never moved into Orange Park himself but we know from this that at least five bungalows in the neighborhood should date to 1915 and they were likely constructed very similarly. Also, from late 1913 through early 1915, the John F. Cox (soon to be the mayor of Lakeland) Realty company slowly sold off lots they had purchased during the initial sale, to include one of the lakefront lots that cost \$1,250. He must have gotten a discount on his purchase as a realtor as he listed each lot for what its original price would have been from FGLC. Either that or he was simply trying to break even on his investments. Eventually lots sold and homes slowly began construction; however, the buying was not as brisk as the advertisements may have implied. By February 1915, while John Cox Realty was still trying to sell one of its own lots, the FGLC announced an auction for February 25, to finally dispose of its last 16 lots.

One has to wonder though how much profit FGLC really made as all sixteen lots auctioned, and two others, they still owned during 1914 had property taxes unpaid. Notice was posted that the properties in arears (any properties, not just in Orange Park) would go to auction December 5, 1915, for failing to pay their 1914 property taxes. Thirty-two lots in Orange Park were listed and eighteen of those were owed by FGLC during 1914. I wonder what the new property owners thought when they was their newly purchased land on the county's auction list.

Returning to the construction of homes, in addition to the five built by Thomas Waring, for resale, there are a few others built in 1914 and occupied. Following is a list of the 83 homes to date, their age, and any information of their first owners available. Red indicates more research is needed. With our present situation, public buildings closed and pandemic, I will be unable to access the respective research documents at the public library for some time. That said, I think the state of information about to be presented is as accurate as it can be for now and, for the purposes of the Century Home Project, and will not change the results of my findings substantially. Table 1 lists homes by age while Table 2 lists homes by address. For the purposes of the Century Home project, we can be sure there are some thirty homes at least 100 years of age.
